


HOW TO MINT A BENTLEYBAE NFT?!

BentleyBae NFT is on the Ethereum blockchain, you'll need to have a Metamask wallet:


Step 1: Download/Open Metamask and click the

browser icon:




Step 2: Type in www.BentleyBae.com
